Railway Express Agency, Inc.*, 466 F.2d 1015 (2d Cir.1972), cert. denied, 409 U.S. 828, 93 S.Ct. 46, 34 L.Ed.2d 70 (1972), the Second Circuit held that a union was not liable to an employee of a train company for the latter's loss of employees who refused to work when offered employment by the union.
