Notwithstanding, section 7.75(c), which is part of article 7.75 of the Texas Business and Commerce Code, provides the following: "A party who files suit under Section 25.01 against a corporation as an individual and as a representative of a corporation shall name all of the directors of the corporation as defendants and shall give the corporation proper notice of the suit." Section 25.01 of the Texas Business and Commerce Code provides that corporations are entitled to trial by jury in suits in which the real controversy is between the corporation and any other party. Section 7.75(c), however, applies only when suit is filed "against a corporation as an individual and as a representative of a corporation" and requires that the corporation receive notice of the suit. Here, the trial court dismissed the cause, not because it found the pleadings insufficient as to the plaintiff, but because of a lack of personal jurisdiction over the defendant. The purpose of section 7.75(c) is to protect a corporation against the possibility that a judgment rendered against it will be a "cloud on its title" to its property. *Keene Corp. v. Gilbert*, 837 S.W.2d 231, 244 (Tex.App. ¶ Fort Worth 1992), rev'd on other grounds, 867 S.W.2d 725 (Tex.1993). Therefore, if the property of the corporation is not involved in the underlying litigation, it does not matter that the corporate officers and directors may have been improperly served or that the officers and directors may have never received notice of the suit. The underlying lawsuit involved the plaintiff and a corporation, Jamestown. After the suit was filed, Jamestown was dismissed from the lawsuit without prejudice. Under these circumstances, we hold that the filing of suit against the corporation as an individual and as a representative is not the equivalent of naming the corporate officers and directors, and to hold otherwise would be to broaden the purpose of section 7.75(c) beyond the scope intended by the legislature.[1] In our opinion, the trial court did not

err in dismissing the cause of action against the individual corporate officers and directors. WALTER E. HOFFMAN, J. DISSENTING OPINION, joined by J. CAYCE, C.J. WALTER E. HOFFMAN, Justice, dissenting. I respectfully dissent. I would hold that when a corporation is sued as an
